THIS SUBSTITUTION OF TRUSTEE, made this the 1 day of November, 2010, by Wells Fargo Bank, N.A. (Lender), by and through its Attorney-in-Fact, Jay A. Kania, Document Execution Officer for the Law Firm of Kania and Kania, P.A., party of the first part, to Richard J. Kania, Amanda Beedie, and Kate Helmick, Substitute Trustee, party of the second part;

WITNESSETH:

WHEREAS, Lender is the owner of all the indebtedness secured by a certain deed of trust executed on December 27, 2007, in the amount of \$104,277.40 by Robert Patrick Ryan and Joyce Ann Ryan to Trste, Inc., Trustee for Wachovia Bank, National Association, Beneficiary, and recorded in Deed of Trust Book 2806, Page 3764, Forsyth County Registry;

And Whereas, Wells Fargo Bank, N.A. is the current owner and holder of said deed of trust and the note secured thereby.



NOW, THEREFORE, pursuant to the authority contained in said deed of trust allowing Lender to remove the trustee and appoint a substitute trustee, the Lender hereby appoints the party of the second part, Richard J. Kania, Amanda Beedie, or

Kate Helmick as Substitute Trustee in the above-referred deed of trust in the place and stead of the trustee therein designated or any previously appointed substitute trustee(s), with all the powers, duties, and obligations conferred in said deed of trust upon the trustee originally named therein. In the event that Lender is the high bidder at any foreclosure sale of the property described in the deed of trust referenced above, the Substitute Trustee shall also have the authority to assign the winning bid of Lender to any other party on behalf of the Lender. Such assignment may be evidenced by a statement in any Substitute Trustee's deed conveying the property foreclosed to the effect that Lender has assigned its bid to the Grantee of such Substitute Trustee's deed.


