THIS DEED OF RELEASE, made this the 3rd day of December, 2010, by
BRANCH BANKING AND TRUST COMPANY (hereinafter referred to as "Lender"), to V.
SALEM DEVELOPMENT CORPORATION, of Forsyth County, North Carolina (hereinafter
referred to as "Grantee");

WITNESSETH:

WHEREAS, Grantee executed to BB&T Collateral Service Corporation, as Trustee for
Lender, a deed of trust dated April 20, 2009, and recorded in Book 2885 at Page 2822 in the Office
of the Register of Deeds of Forsyth County, to secure the payment of obligations to Lender in the

Being known and designated as Lot No. 4, as shown on a map entitled "Partition of Lots 1, 102, and 103", prepared for Dr. Blucher E. Taylor, being recorded in Plat Book 49, page 191, in the Office of the Register of Deeds of Forsyth County, North Carolina, reference to which is hereby made for a more particular description.

TO HAVE AND HOLD the aforesaid released premises unto the Grantee and its successors and assigns, free and discharged from the lien of said Deeds of Trust. This deed of release shall affect only the land herein described and the Deeds of Trust and the obligations thereby secured shall otherwise remain in full force and effect.

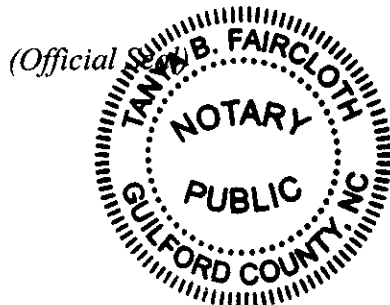
