RELEASE DEED

THIS DEED, made and entered into this 18th day of January, 2011, by and between **BB&T Collateral Service Corporation**, Trustee (hereinafter referred to as Trustee) for **Branch Banking & Trust Company**, party of the first part, (hereinafter collectively referred to as Note Holder), **V. Salem Development Corporation**, and (hereinafter referred to as part of the second part).

WITNESSETH

WHEREAS, said party of the second part heretofore executed to said Trustee, a certain deed of trust dated May 4, 2007, and recorded in Book 2750, Page 4451, Forsyth County Registry, to secure a certain note therein set out and payable to the said Note Holder, party of the first part; and

WHEREAS, said party of the second part has requested the said Trustee, and the said Note Holder, party of the first part, to release from the lien of said deed of trust so much of the land therein conveyed as is hereinafter described, and said Note Holder, party of the first part has agreed to do so and has requested said Trustee to join in said release.

NOW, THEREFORE, said parties of the first part, have remised and released and by these presents do remise, release and forever quitclaim unto the said party of the second part and his heirs and assigns certain lands situate in Forsyth County, North Carolina, and more particularly described as follows:

BEING KNOWN AND DESIGNATED as a 0.57 acre parcel described as New Lot B, as shown on the Map entitled "A Proposed Division for V. Salem Development Corp." as recorded in Plat Book 52 at Page 44, in the Office of the Register of Deeds for Forsyth County, North Carolina, reference to which is hereby made for a more particular description.

TO HAVE AND TO HOLD said lands to him, the said party the second part, and his heirs and assigns, free and discharged from the lien of said deed of trust herein above referred to.

But it is understood and agreed that this release shall apply only to so much of said land as are herein expressly described and conveyed, and that the remainder of said lands shall remain subject to the lien of said deed of trust, and shall remain in full force and effect.

When reference is made to the Trustee, any Part or Parties, or to the Note Holder or the Note, the singular shall include the plural and the masculine shall include the feminine and the neuter.

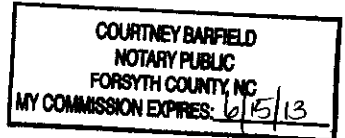
