DEED

THIS DEED, made this the 11 day of October, 1974, by THE BANK OF NORTH CAROLINA, N.A., Executor and Trustee under the Will of EDWARD L. HALL; L & H LAND COMPANY, a North Carolina partnership; D. E. CARROLL and wife, DOROTHY I. CARROLL; JAMES L. WILLIAMS and wife, JEAN R. WILLIAMS, parties of the first part; to JOHN A. DOMBALIS and wife, MARGARET A. DOMBALIS and PETE G. BAMBALIS and wife, NITSA A. BAMBALIS, parties of the second part.

WHEREAS, L & H Land Company was a North Carolina partnership (see assumed name file Number 3502) composed of Edward L. Hall, D. E. Carroll and James L. Williams, General Partners,

WHEREAS, Edward L. Hall died testate in Forsyth County, North Carolina, on January 1, 1973, and the remaining partners execute this Deed for the partnership and individually together with their spouses.

WHEREAS, the Will of Edward L. Hall granted the power to sell to the Bank of North Carolina, N.A. as his Executor and Trustee, and Whereas the Bank of North Carolina, N.A. as such Executor and Trustee deems it in the best interest of said estate and the Trust created thereunder to sell the within described real estate.

THEREFORE, For and in consideration of the payment to the parties of the first part the sum of Ten Dollars (\$10.00 o.v.c.) and other valuable consideration, the parties of the first part do hereby bargain, sell and convey unto the parties of the second part, their heirs and assigns, the tract or parcel of land in Winston Township, Forsyth County, North Carolina more particularly described as follows:

BEING a lot located on the north side of Sprague Street, and being known and designated as Lot No. 31, as shown on the map of Bahnson Place, as recorded in Plat Book 1, page 41, in the office of the Register of Deeds of Forsyth County, North Carolina, to which map reference is hereby made for a more definite and particular description,

TO HAVE AND TO HOLD the aforesaid tracts or parcels of land and all privileges and appurtenances thereunto belonging to the said parties of the second part and their heirs and assigns.

And the Bank of North Carolina, N.A. Executor and Trustee under the Will of Edward L. Hall hereby covenants that it has not placed or suffered to be placed any presently existing liens or encumbrances on its one-third undivided interest in said premises, and that it will warrant and defend the title to the same against the lawful claim of all persons claiming by, through, under, or on account of the Bank of North Carolina N.A. as Executor and Trustee under the Will of Edward L. Hall, insofar as it is its duty to do so, by virtue of its office as Executor and Trustee under the Will

of Edward L. Hall, but no further.

And the said D. E. Carroll and wife, Dorothy I. Carroll and James L. Williams and wife, Jean R. Williams, do covenant that they are seized of a two-thirds undivided interest in said premises in fee, and have the right to convey same in fee simple; that the same are free from encumbrances and that they will warrant and defend the said title to the same against the claims of all persons whatsoever, save and except utility service line easements, restrictions of record, and 1974 taxes which are to be prorated, and save and except a Deed of Trust to 1st Fed. S&L Assoc. which grantees herein assume and agree to pay in full.

IN WITNESS WHEREOF, the Bank of North Carolina, N.A., Executor and Trustee under the Will of Edward L. Hall, has caused this instrument to be executed in its name by its President, attested to by its Secretary, and its Corporate Seal affixed hereto, and D. E. Carroll and wife, Dorothy I. Carroll and James L. Williams and wife, Jean R. Williams, and D. E. Carroll and James L. Williams as General Partners of L & H Land Company, have hereunto set their hands and seals all the day and year first above written.
