ARTICLES OF INCORPORATION

OF

B & E ENTERPRISES, INC.

We, the undersigned, natural persons of the age of twenty-one years or more, do hereby associate ourselves into a business corporation under the laws of the State of North Carolina, as contained in Chapter 55 of the General Statutes of North Carolina, entitled "Business Corporation Act", and the several amendments thereto, and to that end do hereby set forth:

ARTICLE I

The name of the corporation shall be B & E ENTERPRISES, INC.

ARTICLE II

The period of duration of the corporation shall be unlimited.

ARTICLE III

The purposes for which the corporation is organized are:

- (a) To buy, sell, retail, wholesale, barter, exchange, manufacture, repair and service and deal generally in the retail sale of mobile homes, trailers, camping trailers or recreational vehiclesof any type; and to do all other things subsidiary, necessary or convenient for carrying out and into effect the main purposes and objects of the organization of the corporation.
- (b) To buy and hold and sell or own real property, and may mortgage, pledge or convey the same. May purchase, own, convey, sell, mortgage or otherwise dispose of machinery, tools, supplies or other personal property used in, about and in connection with its business.
- (c) That it may borrow money and issue stock, notes, debentures and otherwise pledge its property by mortgage deeds of trust, as security or may sell or pledge its notes, securities, or bonds in payment of securing its indebtedness in the usual course of business.

- (d) That it may purchase the business, goodwill, notes, securities, liens, mortgages or other classes of securities, the merchandise, fixtures, and leases together with any property it may own of any retail or wholesale mobile home, trailer, camping trailer or recreational vehicle of any type, either as an operated business or as a closed or distressed business and assume its liabilities, stock, notes or other evidence of indebtedness in whole or in part, and issue stock or otherwise secure said indebtedness by lien on its property or securities in payment for the same, be the said business, a corporation, copartnership or individual business.
- (e) That this corporation may enter into a partnership, whether it be limited or general, with any other corporation, partnership or individual in the operation of a similar or the same type of business or a related business of any kind.
- (f) That it may issue stock and sell the same, and otherwise pledge its property in payment of any capital assets acquired by said corporation that is not contrary to law or the objects of this business. It may purchase its own securities or stock and hold the same, and receive any interest or dividend payable on the same, or may pledge the same, or may retire it.

And, in order to properly prosecute the objects and purposes above set forth the corporation shall have full power and authority to purchase, lease or otherwise acquire, hold, mortgage, convey and otherwise dispose of all kinds of property, both real and personal, both in this state and in all other states, territories and dependencies of the United States; to purchase the business, goodwill and all other property of any individual, firm or corporation as a going concern and to assume all its debts, contracts and obligations, provided said business is authorized by the powers contained herein; to construct, equip, and maintain buildings, work shops, plants and factories, to install machinery and appliances, to operate the same by hand, steam, water, electricity or other motive power, and generally to perform all acts which may be deemed necessary or expedient for the proper and successful prosecution of the objects and purposes for which the corporation is created.

(g) To carry on any business that is adapted, directly or indirectly to add to the value of the corporations property and the profits of its principal business as herein set forth.

ARTICLE IV

The corporation shall have authority to issue 100,000 shares of no par value shares.

ARTICLE V

The minimum amount of consideration to be received by the corporation for its shares before it shall commence business is \$300.00 in cash or property of equivalent value.

ARTICLE VI
