of Forsyth County, North Carolina, part ies of the second part; Witnesseth that the said part y of the first part, in consideration of (\$ 100.00 & OVC ) One hundred dollars and other valuable considerations to her paid by the said part ies of the second part, the receipt of which is hereby acknowledged, has ~~been~~ bargained and sold, and by these presents does bargain, sell and convey unto the said part ies of the second part and their heirs a tract or parcel of land in Forsyth County, North Carolina, in

Middlefork Township, and bounded as follows: TRACT NO. ONE: BEGINNING at an iron stake in the West margin of Mickey Mill Road, H. E. White corner; thence with H. E. White line North 87° 45' West 300.0 feet to iron stake H. E. White corner; thence with H. E. White line South 16° 45' West 200.0 feet to iron stake H. E. White corner in W. E. Mabe's line; thence with W. E. Mabe's line South 87° 45' East 300.0 feet to iron stake W. E. Mabe's corner in the west margin of Mickey Mill Road; thence with the west margin of Mickey Mill Road, North 16° 45' East 200.0 feet to the BEGINNING, containing 1.37 acres, more or less.
