THIS DEED Made this the 12th day of January, 1979, by CLEMMONS WEST DEVELOPMENT CO., a Partnership of Forsyth County, North Carolina, party of the first part to E & A CONSTRUCTION CO. INC., a Corporation of Forsyth County, North Carolina, party of the second part; Witnesseth that the said party of the first part, in consideration of Ten Dollars and other valuable consideration (\$10.00 o.v.c.) to it paid by the said party of the second part, the receipt of which is hereby acknowledged, has bargained and sold, and by these presents does bargain, sell and convey unto the said party of the second part and its successors a tract or parcel of land in Forsyth County, North Carolina, in Clemmons Township, and bounded as follows:

BEING KNOWN AND DESIGNATED as Lot 237, as shown on the Plat of Clemmons West, Section 5, as recorded in Plat Book 27, page 48 (2 sheets) in the Office of the Register of Deeds of Forsyth County, North Carolina, reference to which is hereby made for a more particular description.

THIS CONVEYANCE is made subject to the Declaration of Restrictive Covenants, conditions and reservations recorded in Book 1262 page 1650, of the Forsyth County Registry.

TO HAVE AND TO HOLD the aforesaid tract or parcel of land all privileges and appurtenances thereunto belonging to the said party of the second part and its successors and assigns forever. And the said party of the first part does covenant that it is seized of said premises in fee and has the right to convey the same in fee simple; that the same are free from encumbrances; and that it will warrant and defend the said title to the same against the claims of all persons whatsoever, save and except easements and restrictions of record.
