ARTICLES OF INCORPORATION

OF

E & A CORPORATION

We, the undersigned natural persons of the age of Eighteen (18) years, do hereby associate ourselves into a business corporation under the laws of the State of North Carolina, as contained in Chapter 55 of the General Statutes of North Carolina, entitled "Business Corporation Act", and the several amendments thereto, and to that end do hereby set forth:

- (1) The name of the corporation is "E & A Corporation".
- (2) The period of duration of the corporation shall be perpetual.
- (3) The purposes for which the corporation is organized are:
- a. To operate a restaurant, or other eating establishment, for the purpose of serving food and drink to the general public and otherwise to deal in the purchase, preparation, and sale of food on and off of the corporate premises; and

To buy, sell, at wholesale or at retail, any legal alcoholic beverage, including, but not limited to, beer, non-fortified wine, fortified wine or any legal liquor for consumption on the premises of any business establishment of the corporation; to hold and apply for any necessary alcoholic beverage control licenses or permits;
