QUITCLAIM DEED

KNOW ALL MEN BY THESE PRESENTS, that E&A CONSTRUCTION CO., INC., TRACLIN, INC., UNITED CITIZENS BANK, UNITED SAVINGS & LOAN ASSOCIATION, ROBERT W. PORTER, TRUSTEE, and RICHARD E. STOVER, TRUSTEE, of the State of North Carolina, parties of the first part, and KOYT EVERHART BUILDING CO., INC., party of the second part;

WITNESSETH:

WHEREAS, E&A Construction Co., Inc., is the owner of Lot 252 as shown on the Plat of Clemmons West, Section 5, recorded in Plat Book 27, page 48(2), Forsyth County Registry, and has issued its note secured by a deed of trust to Robert W. Porter, Trustee for United Citizens Bank recorded in Book 1270, page 1435 of the Forsyth County Registry, and

WHEREAS, Traclin, Inc., is the owner of Lot 253 on the aforesaid plat and has issued its note secured by a deed of trust to Richard E. Stover, Trustee for United Savings & Loan Association recorded in Book 1275, page 366 of the Forsyth County Registry, and

WHEREAS, it has been discovered that the irons marking the corners of Lots 252, 253 and 254 on the ground are not in accordance with the plat of record in Plat Book 27, page 48(2) of the Forsyth County Registry, and

WHEREAS, the dwelling houses have been constructed in accordance with the irons on the ground and it is necessary to cause the plat to conform to the irons in place which will require a small strip off the western sides of Lots 252 and 253 to be included in Lot 254 as shown on the revised plat and the grantors are willing to so convey.

NOW THEREFORE, for and in consideration of ONE DOLLAR received of KOYT EVERHART BUILDING CO., INC., the parties of the first part have hereby released and forever quitclaimed, unto KOYT EVERHART BUILDING CO., INC., and its successors and assigns forever, all such right, title and interest, as they have in or to all that parcel of land lying in Clemmons Township, Forsyth County, North Carolina, described as follows:

BEING KNOWN AND DESIGNATED as Lot 254 as shown on the Revised Map of Clemmons West Section 5, Sheet 2 of 2, recorded in Plat Book 27, page 114, in the Office of the Register of Deeds of Forsyth County, North Carolina, to which reference is hereby made for a more particular description.

Except as herein released the deeds of trust to United Citizens Bank and United Savings & Loan Association as to the remainder of the property covered by their deeds of trust remain in full force and effect.

TO HAVE AND TO HOLD the above-released premises unto the said KOYT EVERHART BUILDING CO., INC., its successors and assigns, to its and their only proper use and behoof forever; so that neither of us nor any person, in our name and behalf, shall or will hereafter claim or demand any right or title to the premises, or any part thereof; but they and each of them shall, by these presents, be excluded and forever barred.




