THIS CORPORATION DEED, made this 15th day of November, 19 79, by O & A, Inc., a Corporation of Winston-Salem, Forsyth County,

North Carolina, party of the first part, to Ervin C. Oakley of Forsyth County, North Carolina, part Y of the second part, WITNESSETH: that said party of the first part in consideration of One Hundred and no/100 Dollars

(\$ 100.00) and other valuable considerations to it paid by part Y of the second part, receipt of which is hereby acknowledged, has bargained and sold and by these presents does bargain, sell and convey to said part Y of the second part and his heirs and assigns, a certain tract or parcel of land in Winston Township, Forsyth County, North Carolina, bounded as follows:

BEGINNING at an iron stake in the eastern right-of-way line of Patterson Avenue (Old Highway 52), said iron stake being 30.0 feet north 28° 22' west from an iron stake, the northwest corner of the G. T. Caudle and P. P. Link property as described in Deed Book 877, page 478, Forsyth County Registry; and thence from said BEGINNING point and running with the said eastern right-of-way line, north 28° 22' west 209.95 feet to an iron stake, said iron stake being a southwest corner of that property conveyed to Tzu Ben Chen and wife, Lai-ho Chen, as recorded in Book 1259, page 1300, Forsyth County Registry; thence with a southern boundary line of the Chen property, north 61° 24' east 199.95 feet to an iron stake; thence continuing with the Chen boundary line, south 28° 38' 23" east 148.88 feet to an iron stake, said iron being the northwest corner of that property conveyed to Tzu Ben Chen and wife, Lai-ho Chen in Book 1293, page 37; thence continuing with the Chen boundary line south 28° 38' 23" east 41.38 feet to an iron stake; thence south 28° 38' 23" east 93.70 feet to an iron stake; thence south 81° 38' 20" west 214.24 feet to the point and place of BEGINNING, as shown on a survey dated January 31, 1979 by Joseph E. Franklin, Registered Land Surveyor.
