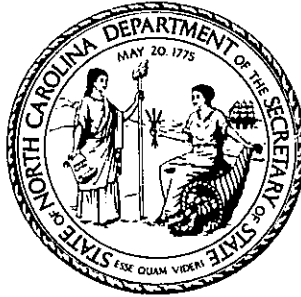

ARTICLES OF INCORPORATION

THAL EURE  
SECRETARY OF STATE

OF

W & A CORPORATION

The undersigned, being of the age of eighteen years or more, does hereby make and acknowledge these Articles of Incorporation, for the purpose of forming a business corporation under and by virtue of the laws of the State of North Carolina:

ARTICLE I.

The name of the corporation is W & A CORPORATION.

ARTICLE II.

The period of duration of the corporation is unlimited.

ARTICLE III.

The purposes for which the corporation is organized are:

(a) To engage in the business of operating an entertainment business and a confessionary; and

(b) To engage in any lawful act or activity for which corporations may be organized under Chapter 55 of the General Statutes of North Carolina.

ARTICLE IV.

The corporation shall have authority to issue One Hundred Thousand (100,000) shares of common stock at One and No/100 Dollar (\$1.00) par value.

ARTICLE V.

The minimum amount of consideration to be received by the corporation for its shares before it shall commence business is One Dollar (\$1.00) in cash or property of equivalent value.

ARTICLE VI.

The shareholders of the corporation shall have no preemptive right to acquire additional or treasury shares of the corporation.

ARTICLE VII.

The address of the initial registered office of the corporation in the State of North Carolina is 2860 Marguerite Drive, Winston-Salem, Forsyth County, North Carolina 27106, and the name of its initial registered agent at such address is Wesley J. Pack.

ARTICLE VIII.

The number of directors constituting the initial board of directors shall be one (1); and the name and address of the person who is to serve as director until the first meeting of shareholders or until his successor be elected and qualify, is:
