

ARTICLES OF INCORPORATION

OF

TATE ID AT A TAKE

D & B TOOLING SERVICE, INC.

I, the undersigned, being of full age, do make and acknowledge these Articles of Incorporation for the purpose of forming a business corporation under and by virtue of the laws of the State of North Carolina.

ARTICLE I

The name of the corporation shall be D & B Tooling Service, Inc.

ARTICLE II

The purposes for which the corporation is organized are:

- (a) To engage in the manufacture and wholesale and retail sale of machine tools and machine tool parts.
- (b) To engage in any other lawful activity including, but not limited to, construing, manufacturing, raising or otherwise caring for any type of structure, commodity or livestock whatsoever, processing, selling, producing, factoring, or distributing any type of property whether real or personal; extracting and processing natural resources; disseminating information or advertisement through any medium whatsoever; performing all personal services of any nature; and engaging or entering into or serving any type of management, investigative, advisory, promotional, protective, insurance, guarantyship, suretyship, fiduciary or representative capacity or relationship for any person or corporation whatsoever.

The corporation shall have authority to issue One Hundred Thousand (100,000) shares of common stock at One and No/100 Dollars (\$1.00) par value, the total value of said stock not to exceed One Hundred Thousand and No/100 Dollars (\$100,000.00).
