



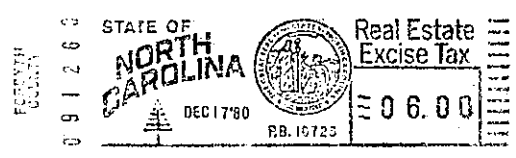

 bounded as follows:

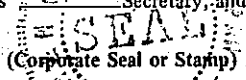
Being known and designated as Lot 10 as shown on the map of H & H Construction

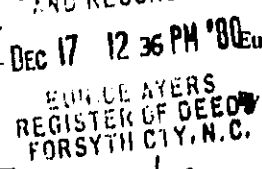
