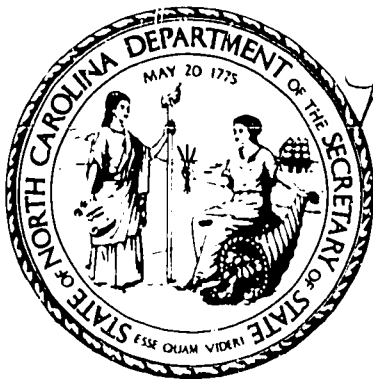

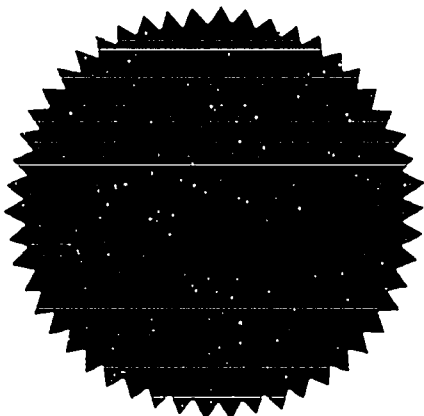

ARTICLES OF INCORPORATION

OF

E. AND A. ALUMINUM, INC.

WE, the undersigned residents of the State of North Carolina and all being of legal age, do hereby associate ourselves into a business corporation under and by virtue of the laws of the State of North Carolina, specifically under and by virtue of the laws of the State of North Carolina as found and set forth in North Carolina General Statute, Chapter # 55, entitled Business Corporation Act, and in support thereof, state as follows:

FIRST

That the name of the Corporation shall be the E. AND A. ALUMINUM, INC.; and,

SECOND

That the period of duration of the Corporation shall be perpetual; and,

THIRD

That the purposes for which the said Corporation is established are as follows:

1. To engage in the business of buying and selling scrap metals, including aluminum and steel and iron and other scrap metals, and to engage in the business of buying and selling any other scrap product or merchandise; and,
2. To construct, improve and develop any real estate or property or structures thereon, whether the said real property is owned by the said Corporation outright, partially or not at all.

3. To purchase, sell and exchange any securities, notes or any other evidence of ownership or indebtedness which is associated or incident to the operation of this Corporation, and the purpose of the corporation shall include, but shall not be limited to, the borrowing and lending of all necessary funds for the operation of the said Corporation; and,
4. To purchase, sell and exchange any stock in business ventures and all and any real and personal, tangible or intangible, property appertaining thereto, and to operate the said business ventures for the purpose of such purchase, sale and exchange, and to loan to any other business corporation monies and to receive collateral therefrom; and,
5. To purchase, sell and exchange and operate such personal property, tangible and intangible, that is believed to be necessary in the every day operation of this Corporation. This purpose shall include but shall not be limited to, the ownership and operation of a fleet of motor vehicles and other equipment, the ownership and maintenance of any and all types of tools, equipment and supplies, and the issuance and sale of corporate stock; and,
6. To engage in any lawful act or activity for which corporation may be organized under and by virtue of the laws of the State of North Carolina as set forth in North Carolina General Statute # 55 entitled Business Corporation Act; and,
7. To do any and all acts that are necessary in the operation of the business of this Corporation and the preservation of the assets thereof.

#### FOURTH

That the Corporation shall have the authority to issue ONE HUNDRED THOUSAND (100,000) shares of common stock with a par value of ONE DOLLAR (\$1.00) per share; and,

#### FIFTH

That the minimum amount of consideration for its shares to be received by the Corporation before it shall commence business shall be the amount of SEVEN THOUSAND FIVE HUNDRED DOLLARS (\$7,500.00).
