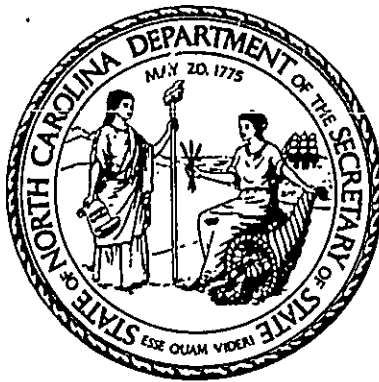

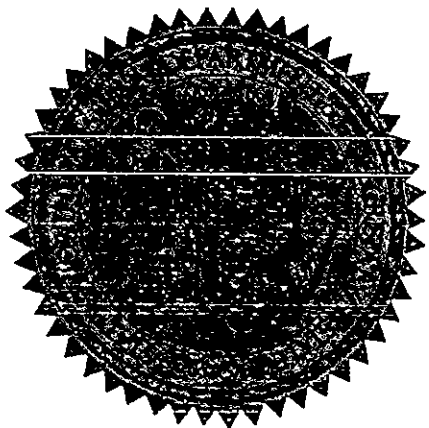

K & S AUTO SALES & CLEAN-UP SHOP, INC.

The undersigned, being of the age of eighteen years or more, does hereby make and acknowledge these Articles of Incorporation for the purpose of forming a business corporation under and by virtue of the laws of North Carolina:

1. The name of the corporation is K & S Auto Sales & Clean-up Shop, Inc.
2. The period of duration of the corporation is perpetual.
3. The corporation is organized for the purpose of engaging in any lawful act or activity for which corporations may be organized under Chapter 55 of the General Statutes of the State of North Carolina.
4. The corporation shall have authority to issue 100,000 shares with a par value of \$1.00 per share. The shares may be divided into classes. The preferences, limitations and relative rights in respect of the shares shall be fixed by resolution of the Board of Directors.
5. The minimum amount of consideration to be received by the corporation for its shares before it shall commence business is \$100.00 in cash or property of equivalent value.
6. The address of the initial registered office of the corporation in North Carolina is 5717 Country Club Road, Forsyth County, North Carolina; the name of its initial registered agent at such address is William B. Kirby. (City of Winston-Salem)
7. The number of directors constituting the initial board of directors shall be one; the name and address of the person who is to serve until the first meeting of shareholders, or until their successors be elected and qualify, are: William B. Kirby of 5717 Country Club Road, Forsyth County, North Carolina.
8. The name and address of the incorporator are: William B. Kirby of 5717 Country Club Road, Forsyth County, North Carolina.
