

SELT TY OF STATE AKIJORS The undersigned, being of the age of eighteen years or more, does hereby make and acknowledge these Articles of Incorporation for the purpose of forming a business corporation under and by virtue of the laws of North Carolina:

- 1. The name of the corporation is K & S Auto Sales & Clean-up Shop, Inc.
- 2. The period of duration of the corporation is perpetual.
- 3. The corporation is organized for the purpose of engaging in any lawful act or activity for which corporations may be organized under Chapter 55 of the General Statutes of the State of North Carolina.
- 4. The corporation shall have authority to issue 100,000 shares with a par value of \$1.00 per share. The shares may be divided into classes. The perferences, limitations and relative rights in respect of the shares shall be fixed by resolution of the Board of Directors.
- 5. The minimum amount of consideration to be received by the corporation for its shares before it shall commence business is \$100.00 in cash or property of equivalent value.
