



ARTICLES OF INCORPORATION

J & G TRANSPORTATION, INC.

The undersigned, being of the age of eighteen (18) years or more, does hereby make and acknowledge these Articles of Incorporation for the purpose of forming a business corporation under and by virtue of the laws of the State of North Carolina:

- 1. The name of the corporation is J & G Transportation, Inc..
- 2. The period of the duration of the corporation is perpetual.
- 3. The purposes for which the corporation is organized are:
- (a) To broker and otherwise provide transportation services; and
- (b) To engage in any lawful act or activity for which corporations may be organized under Chapter 55 of the General Statutes of North Carolina.
- 4. The corporation shall have the authority to issue 100,000 shares with a par value of \$1.00 per share.
- 5. The minimum amount of consideration to be received by the corporation for its shares before it shall commence business is One Hundred (\$100.00) in cash or property of equivalent value.
- 6. The shareholders of the corporation shall have no preemptive right to acquire additional or treasure shares of the corporation.
- 7. The address of the initial registered office of the corporation within the State of North Carolina is Suite 522, NCNB Plaza, Winston-Salem, Forsyth County, North Carolina; and the name of its initial registered agent at such address is Michael R. Greeson, Jr.
- 8. The number of directors constituting the initial Board of Directors shall be two (2); and the names and addresses of the persons who are to serve as directors until the first meeting of shareholders, or until their successors be elected and qualify, are:


