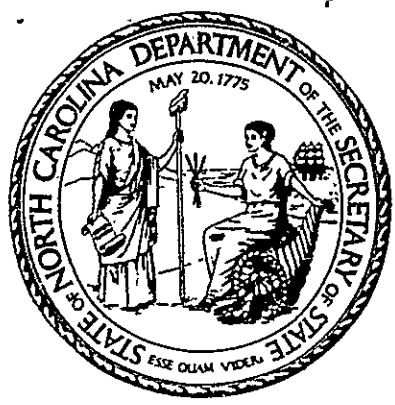

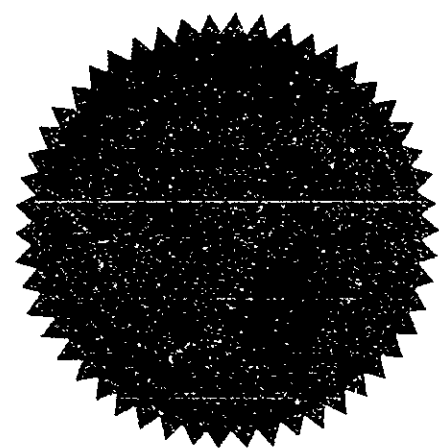

ARTICLES OF INCORPORATION

OF

T & T STEVENSON BUILDING COMPANY

I, the undersigned natural person of the age eighteen years of age or more, do hereby form a corporation under the laws of the State of North Carolina, as contained in Chapter 55 of the General Statutes of North Carolina, entitled "Business Corporation Act," and the several amendments thereto, and to that end do hereby set forth:

1. The name of the corporation is: T & T Stevenson Building Company.
2. The period of duration of the corporation shall be perpetual.
3. The purpose for which the corporation is organized is to own and operate a general residential and commercial building company and to engage in any lawful act or activity for which corporations may be organized under Chapter 55 of the North Carolina General Statutes, as amended from time to time.
4. The total number of shares of stock the corporation is authorized to issue is One Hundred Thousand (100,000), having a par value of One Dollar (\$1.00) per share.
5. The minimum amount of consideration for its shares to be received by the corporation is One Hundred Dollars (\$100.00).
6. The address of the initial registered office of the corporation is 351 N. Peace Haven Road, City of Winston-Salem, County of Forsyth, State of North Carolina 27104, and the name of the initial registered agent is Thomas R. Stevenson at such address.
7. The number of directors of the corporation may be fixed by the bylaws, but shall not be less than the number required by law.



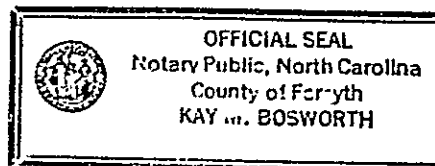
