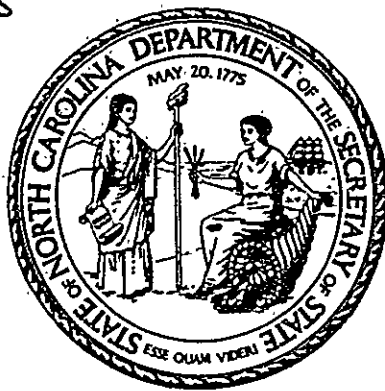

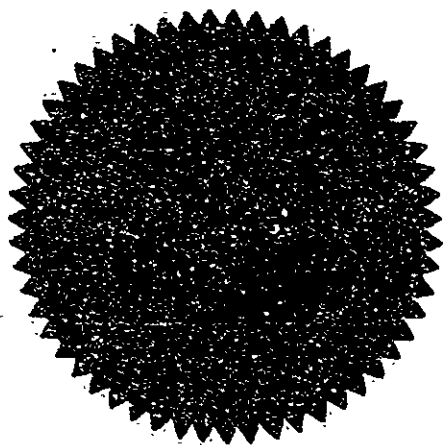

ARTICLES OF INCORPORATION
OF
L & M CONCRETE AND LANDSCAPING, INCORPORATED

The undersigned, being the age of eighteen years or more, does hereby make and acknowledge these Articles of Incorporation for the purpose of forming a business corporation under and by virtue of the laws of the State of North Carolina.

1. The name of the corporation is L & M CONCRETE AND LANDSCAPING, INCORPORATED.
2. The period of its duration is perpetual.
3. The purpose of the corporation is:
 - a. To provide concrete and landscaping services to the general public.
 - b. To engage in any lawful act or activity for which corporations may be organized under the North Carolina Business Corporation Act.
4. The corporation shall have the authority to issue One Hundred Thousand shares of stock, all of one class, with a par value of One Dollar.
5. The minimum amount of consideration to be received by the corporation for its shares before it shall commence business is ONE THOUSAND DOLLARS (\$1,000.00).
6. The address of the initial registered office of the corporation is 1221 Hart Street, Forsyth County, Winston-Salem, North Carolina 27107. The name of the initial registered agent of the corporation is ROBERT E. LEAK.

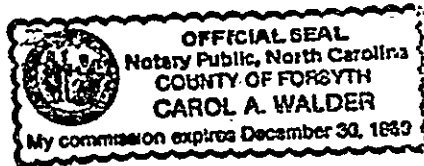
