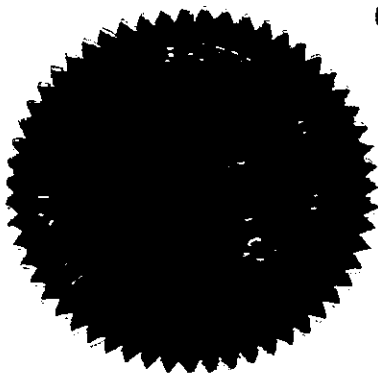
TO THE REGISTER OF DEEDS OF FORSYTH COUNTY:
