

Articles of Incorporation for the purpose of forming a
business corporation under and by virtue of the laws of the THAD EURE
State of North Carolina.

I.

NORTH CAROLINA

The name of the Corporation is B & G BASKET, INC.

II.

The period of duration of the corporation shall be perpetual.

III.

The purposes for which the corporation is organized are:

- (1) Wholesale and retail sales of gifts, crafts, and basketry supplies, including classes on training and instruction to assist in any of the above; and
