

ARTICLES OF INCORPORATION OF N & D CORPORATION

- I, the undersigned, a natural person of the age eighteen (18) years or more, do make and acknowledge these Articles of Incorporation for the purpose of forming a business corporation under and by virtue of the laws of the State of North Carolina, as contained in Chapter 55 of the General Statutes of North Carolina, entitled "BUSINESS CORPORATION ACT," and to that end do hereby set forth:
 - 1. The name of the Corporation is N & D Corporation.
- 2. The period of duration of the Corporation shall be FITE perpetual.
- 3. The purpose or purposes for which the Corporation is organized are:
 - (a) To engage in the restaurant business.
 - (b) To engage in any lawful act or activity for which a corporation may be organized under the BUSINESS CORPORATION ACT.
- 4. The aggregate number of shares which the Corporation shall have authority to issue is One Hundred Thousand (100,000) shares of Common Stock of one class of the par value of One Dollar (\$1.00) per share. Each outstanding share of Common Stock shall entitle the holder to one vote on each matter as to which said holder is entitled to vote under the BUSINESS CORPORATION ACT. No shares shall be entitled to be voted cumulatively except only in the event and to the extent that cumulative voting is specifically required by the BUSINESS CORPORATION ACT.
- 5. The minimum amount of consideration to be received for its shares and for which the Corporation shall commence business is One Hundred Dollars (\$100.00).
- 6. The address of the initial registered office of the Corporation is 215 Executive Park Boulevard, Post Office Drawer 25008, Winston-Salem, North Carolina 27114-5008, in the County of Forsyth, State of North Carolina, and the name of the initial registered agent at such address is House, Blanco & Osborn, P.A.
- 7. The number of Directors of the Corporation may be fixed by the By-Laws but shall not be less than three (3), except as permitted by North Carolina General Statutes § 55-25. The number of Directors constituting the initial Board of Directors shall be two (2) and the names and addresses of the individuals who will serve as the initial Directors until the first meeting of Shareholders, and until their successors are elected and qualified are:


