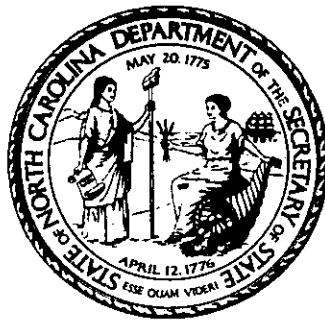

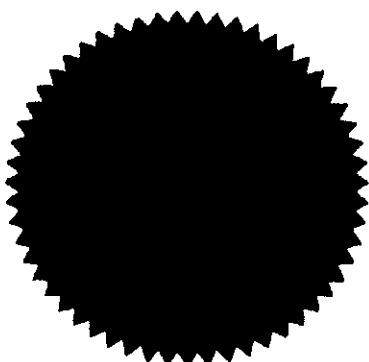

ARTICLES OF INCORPORATION

OF

B & B FABRICATIONS UNLIMITED, INC.

I, the undersigned, being a person of full age, do make and acknowledge these Articles of Incorporation for the purpose of forming a business corporation under and by virtue of the laws of the State of North Carolina:

ARTICLE I.

The name of the corporation shall be B & B Fabrications Unlimited, Inc.

ARTICLE II.

The period of duration of this corporation shall be perpetual.

ARTICLE III.

The purposes for which this corporation is formed are:

(a) to engage in and generally deal in the business of providing metal fabrication and related areas.

(b) to engage in the other lawful activity including, but not limited to, constructing, manufacturing, raising or otherwise producing, and repairing, servicing, storing or otherwise caring for any type of structure, commodity or livestock whatsoever; processing, selling, brokering, factoring, or distributing any type of property whether real or personal; extracting and processing natural resources; transporting freight or passengers by land, sea or air; collecting and disseminating information or advertisement through any medium whatsoever; performing personal services of any nature; and entering into or serving in any type of management, investigative, advisory, promotional, protective, insurance guarantyship, suretyship, fiduciary or representative capacity or relationship for any persons or corporations whatsoever.

ARTICLE IV.

The corporation shall have authority to issue one hundred thousand (100,000) shares of the par value of One and No/100 Dollars (\$1.00) each.

ARTICLE V.

The minimum amount of consideration to be received by the corporation for its shares before it shall commence business is Three Hundred and NO/100 Dollars (\$300.00) in cash or property of equivalent value.

ARTICLE VI.

The initial registered office of the corporation shall be 300 Haled Street, Winston-Salem, Forsyth County, North Carolina 27127 and the name of the initial registered agent at such address is Darold T. Baity.

ARTICLE VII.

The number of directors constituting the intitial Board of Directors shall be two; and the name and address of the persons who are to serve as directors until the first meeting of the shareholders, or until his successor be elected and qualify, are:

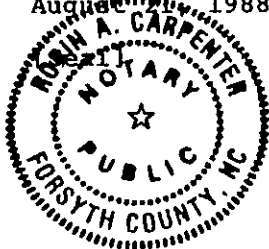
