BEGINNING at an iron stake in the north line of 15th Street, formerly Graham Street, 415 feet east of Patterson Avenue, formerly Depot Street, and 10 feet east of the southwest corner of Lot 19, Block 8, as shown on the map of "Bramlette Place", recorded in the office of the Register of Deeds of Forsyth County, N.C., in Map Book 8, at page 5; running thence through said Lot 19 northerly 140 feet to an iron stake in the south line of a 10-foot alley, 10 feet east of the northwest corner of said Lot 19; thence with the south line of said alley, easterly 50 feet to an iron stake 10 feet east of the northeast corner of said Lot 19; thence through Lot 18, Block 8, of said recorded map, southerly 140 feet to an iron stake in the north line of said 18th Street, 10 feet east of the southwest corner of said Lot 18; thence with the north line of said street westerly 50 feet to the beginning, being the east 40 feet of said Lot 19 and the west 10 feet of said Lot 18 on said recorded map.
