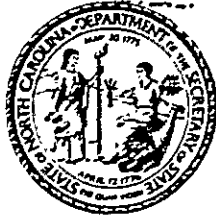

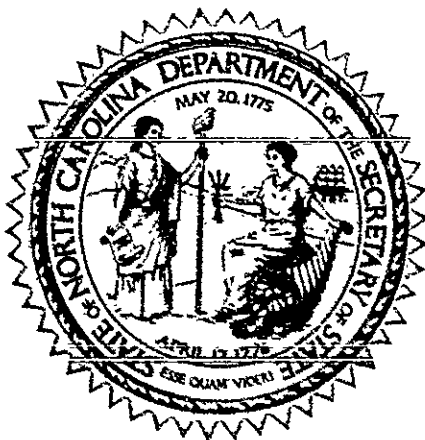

ARTICLES OF INCORPORATION OF  
T. & B. FISHER HOMES, INC.

THE UNDERSIGNED, being of the age of Eighteen (18) years or more, does hereby make and acknowledge these Articles of Incorporation for the purpose of forming a business corporation under and by virtue of the laws of the State of North Carolina.

1. The name of the Corporation shall be T. & B. FISHER HOMES, INC.
2. The period of duration of the Corporation is indefinite.
3. The purpose for which the Corporation is organized are:
  - (a) for the purpose of marketing, sales, installation, and setup of mobile homes.
  - (b) to own, buy, sell, lease, encumber, hold and trade in real property and personal property of all kinds, and
  - (c) to engage in any lawful act or activity for which corporation may be organized under Chapter 55 of the General Statutes of North Carolina.
4. The Corporation shall have authority to issue One Hundred Thousand (100,000) shares with One Dollar par value per share.
5. The minimum amount of consideration to be received by the Corporation for its shares before it shall commence business is Five Hundred Dollars (\$500.00) in cash or property of equivalent value.
6. The shareholders of the Corporation shall have no preemptive right to acquire additional or treasury shares of the Corporation.
7. The address of the initial registered office is 4107 North Patterson Avenue, Winston-Salem, Forsyth County, North Carolina 27105, and the name of the initial registered agent is Marilyn B. Turney.
8. The number of directors constituting the initial board of directors shall be two, and the names and addresses of the persons who are to serve as directors until the first meeting of shareholders or until their successors be elected and qualify are:

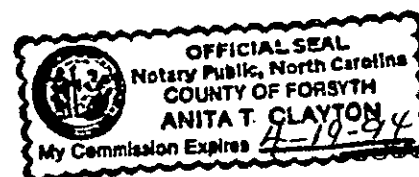
