EXHIBIT "A"

Winston Township, Forsyth County, North Carolina:

BEGINNING at an iron stake in the North right-of-way line of Old Greensboro Road, said iron stake being the Southeast corner of Lot 3 as shown on the map of C. D. Crews property as shown in Plat Book 8, at Page 161, Forsyth County Registry; running thence with the East line of Lot 3, North 04° 34' 50" West 128.22 feet to an iron stake in the Southeast right-of-way line of Hilda Street (the northernmost corner of Lot 3); running thence said right-of-way line, North 48° 14' 05" East crossing an iron stake at 101.59 feet, for a total distance of 217.0 feet to a new iron stake; running thence, South 02° 12' 30" West 265.68 feet to an iron stake, the Southwest corner of Lot 8, in the North right-of-way line of Old Greensboro Road; thence with said right-of-way line, on a curve to the left, a chord call and distance of South 87° 13' 48" West 141.62 feet to the point and place of BEGINNING; said description being in accordance with a survey dated November 29, 1989 by Larry L.
