ASSUMPTION AND RELEASE AGREEMENT

THIS AGREEMENT, made and entered into this the 6th day of April , 19 90, by and between CITY OF WINSTON-SALEM, a municipal corporation of North Carolina (hereinafter called the "Lender"); and

WHEREAS Lender has made certain loans to

(hereinafter called "Original Borrowers", whether one or more persons, corporations, or firms) as evidenced by Notes dated the 31st day of December , 19 85, in the principal amount of \$ 17,750.00 the terms and conditions of which are incorporated herein by reference thereto, and as security for the payment of the Notes, the Original Borrowers executed and delivered to Lender Deeds of Trust of even date therewith conveying certain real property, recorded in Book 1523, page 0328, Forsyth County Registry, the terms and conditions of which are incorporated herein by reference; and the Original Borrowers and/or their successors in title desire (i) to sell the property described in the Deeds of Trust to the Borrowers, (ii) to have the Borrowers assume and agree to pay the Notes in the place and stead of the Original Borrowers or their successors in title, and (iii) to have the Lender release them from their obligation under the said Notes and Deeds of Trust; and

WHEREAS Borrowers desire (i) to purchase the property described in the Deeds of Trust from the Original Borrowers or their successors in title, and (ii) to assume and agree to pay and become liable for; the indebtedness evidenced by the Note and to comply with each and every term, condition, and provision therein in the Deeds of Trust set forth hereinafter, so that the Original Borrowers and/or their successors in title may be released from their obligations under the Notes and the Lender, upon the terms and conditions hereinafter set forth, is willing to consent to such sale, assumption and release.

NOW, THEREFORE, in consideration of the premises stated herein and the Lender's release of the Original Borrowers and/or their successors in title, the Lender and the Borrowers do hereby agree as follows:

- ${\tt l.}$ The creditworthiness of the Borrowers is satisfactory to the Lender;
- 2. Interest payable on the Notes which is and shall be secured by the aforesaid Deed of Trust, shall, from the date of this agreement, accrue at the rate of (3) percent per annum; and, commencing on the lst day of May , 1990, each monthly payment of principal and interest due under the Note shall be \$ 98.44;
- 3. The Borrowers hereby assume and agree to pay any and all sums due under the said Note and Deed of Trust, and the Borrowers further agree to comply with each and every term and condition of the Note and Deed of Trust; and the Borrowers by their execution hereof are and shall be liable, jointly and severally, for all sums of money due under the said Note and Deed of Trust to the same extent and as if the Borrowers had originally executed the Note and the Deed of Trust; and
- 4. The assumption by the Borrowers of the debt evidenced by the said Note and secured by the said Deed of Trust shall and does constitute a release of the Original Borrowers and/or their successors in title from all obligations under the said Note and Deed of Trust.
