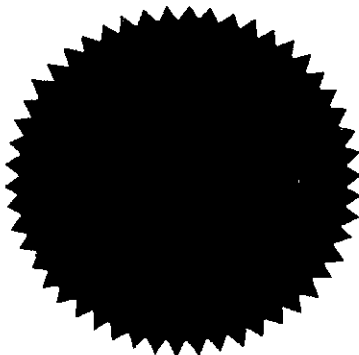

ARTICLES OF INCORPORATION
OF
N AND S CONSTRUCTION, INC.

I, the undersigned, being the age of Eighteen (18) years or more, do hereby form a business under the Laws of North Carolina, as contained in Chapter 55 of the General Statutes of North Carolina, entitled "Business Corporation Act", and the several amendments thereto, and to that end do hereby set forth:

1. The name of the corporation is N and S Construction, Inc.
2. The duration of the corporation shall be perpetual.
3. The location of the principal office is at Highway 66 Old Walkertown Shopping Center, Walkertown, North Carolina, Forsyth County, 27251.
4. The purpose for which this corporation is formed is to serve as a general contractor acquiring contracts from established telephone companies to perform new construction and to install cables underground, and to provide any other services which the telephone company may require.
And further to perform any other activity not inconsistent with Chapter 55 of the North Carolina General Statutes in furtherance of the goals for which this corporation was formed.
5. The authorized capital stock shall be One Hundred Thousand (100,000) shares with a par value of One Dollar (\$1.00) per share.

6. The minimum amount of consideration to be received for its shares and with which the corporation shall commence business is Twenty Thousand Dollars (\$20,000.00).
