57 FIRST AMENDMENT TO LEASE

THIS FIRST AMENDMENT TO LEASE, made as of the first day of April 1990, by L & C INVESTORS, a North Carolina general partnership ("Landlord") and REGAL OLDSMOBILE, INC., a North Carolina corporation, successor by merger to Regal Suzuki, Inc. ("Tenant");

## WITNESSETH:

Whereas, Landlord and Regal Suzuki, Inc. entered into Lease as of August 1, 1988; and

Whereas, Regal Oldsmobile, Inc. is the successor to Regal Suzuki, Inc. by virtue of the merger of Regal Suzuki, Inc. into Regal Oldsmobile, Inc.; and

Whereas, the parties hereto now desire to amend said Lease.

NOW, THEREFORE, for and in consideration of the premises and One Dollar and other valuable considerations (\$1.00 & OVC) the parties do hereby agree that the Lease, dated August 1, 1988 above referred to, is amended as follows:

- The Tenant under the terms of said Lease is Regal Oldsmobile, Inc. a North Carolina corporation, successor by merger to Regal Suzuki, Inc.
- 2. Article IV of the Lease is amended to provide an annual rental of \$144,000.00, payable in equal monthly installments of \$12,000.00 on or before the first day of each month commencing April 1, 1990.
- 3. Except as amended herein, the Lease, dated August 1, 1988 heretofore referred to, remains in full force and effect.
