SUBORDINATION AGRÉEMENT

KNOW ALL MEN BY THESE PRESENTS, that L & S LEASING, INC. is the present holder and owner of a certain Note secured by a Deed of Trust executed by Ralph M. Hoover and wife, Nancy D. Hoover to Norman L. Nifong, Trustee for L & S Leasing, Inc. recorded in Book 1722 at Page 1621 in the Office of the Register of Deeds of Forsyth County, North Carolina establishing a lien upon a certain tract or parcel of land located in Forsyth County, North Carolina and described as follows:

Hoover that they may execute to Republic Bank & Trust Co., Trustee a Deed of Trust upon a portion of the above-described property, specifically described on Exhibit "B" attached hereto, to secure a Note given by Ralph M. Hoover and wife, Nancy D. Hoover to Central Carolina Bank and Trust Company in the sum of Two Hundred Eighty-Five Thousand and No/100 (\$285,000.00) Dollars and that the said Deed of Trust shall be a lien upon the property specifically described on Exhibit "B" attached hereto superior to the lien of the existing Deed of Trust of L & S Leasing, Inc.; and, to carry out the said purpose, L & S Leasing, Inc. does hereby release, remise, and forever quitclaim unto Ralph M. Hoover and wife, Nancy D. Hoover its title to and lien upon the property specifically described on Exhibit "B" attached hereto to the extent, but to the extent only, that the existing Deed of Trust shall be subordinate in lien to a Deed of Trust to Republic Bank & Trust Co., Trustee in the amount of Two Hundred Eighty-Five Thousand and No/100 (\$285,000.00) Dollars.

BUT IT IS EXPRESSLY UNDERSTOOD AND AGREED that except for such subordination, the existing Deed of Trust and any and all singular terms and conditions thereof shall be and remain in full force and effect.
