THIS AGREEMENT, made this 21st day of January, 1993,
 between WACHOVIA BANK OF NORTH CAROLINA, N.A., a national banking association organized under the laws of the United States of America ("the Bank"), T & T Associates, A North Carolina General Partnership

("the Grantors"), and Vickie M. Ball

Substitute
 of Forsyth County, North Carolina ("the Trustee").

WITNESSETH:

WHEREAS, the Grantors have made and issued their promissory note, dated the 15 day of June, 1989,
 made part hereof by this reference as fully as if set out herein verbatim ("the Note"), evidencing an original indebtedness of Five Hundred
Five Thousand and No/100 Dollars
 (\$ 505,000.00) and to secure the Note, the Grantors executed their deed of trust of even date with the Note and recorded in Book 1669

Page 1712 Forsyth County Registry made part herof by this reference as fully as if set out herein verbatim ("the Deed of Trust"); And modified by agreement dated April 30, 1991 and recorded in Book 1718, page 0928, Forsyth County registry AND, WHEREAS, the Bank, as holder and owner of the Note and Deed of Trust and the Grantors mutually desire to modify and amend the provisions of the same in the manner hereinafter set out, it being specifically understood that except as herein modified and amended, the terms and provisions of the Note and the Deed of Trust shall remain unchanged and continue in full force as therein written.
 NOW, THEREFORE, the Bank and the Grantors in consideration of the premises and the sum of One Dollar (\$1.00) to each in hand paid by the other, receipt of which is hereby acknowledged by each, do hereby agree that the Note and the Deed of Trust should be, and the same hereby are, modified and amended to provide as follows:

IT IS MUTUALLY AGREED by and between the parties hereto that nothing herein contained shall impair the security now held or said indebtedness, nor shall waive, annul, vary or affect any provision, condition, covenant, or agreement contained in the Note or the Deed of Trust, except as herein amended, nor affect or impair any rights, powers or remedies under the Note and the Deed of Trust, or either of them. Furthermore, the Bank does hereby reserve all rights and remedies it may have as against all parties secondarily liable for repayment of the indebtedness evidenced by the Note.

The Trustee joins in the execution of this Agreement as evidence of his knowledge of the provisions hereof and his consent to the modifications herein made. This Agreement shall be binding upon any assignee or successor in interest of the parties hereto.

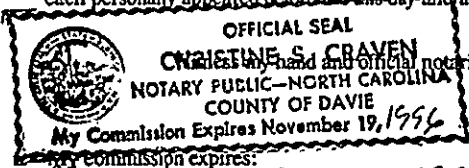

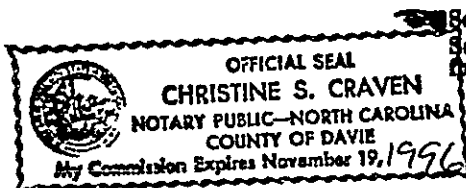

SCHEDULE A

Effective June 1, 1992, the Note shall bear interest at the rate per annum equal to zero percent (0%) above the Bank's "Prime Rate." As used herein, Prime Rate means that interest rate so denominated and set by the Bank from time to time as an interest rate basis for borrowings. The Prime Rate is but one of several interest rate bases used by the Bank, and the Bank lends at rates above and below the Prime Rate. Changes in the Prime Rate shall be effective on the day of such change.
