THIS DEED made this the 29th day of December, 1993, by WACHOVIA BANK OF NORTH CAROLINA, N.A. (formerly Wachovia Bank and Trust Company, N.A.), as Trustee for The Winston-Salem Foundation as provided for in that Revocable Living Trust Agreement dated August 31, 1989, entered into with Otis Brown Parrish for the creation of the Otis B. and Genevieve W. Parrish Endowment Fund, party of the first part, hereinafter referred to as "Grantor"; and SAM C. OGBURN REAL ESTATE COMPANY, INC., party of the second part, hereinafter referred to as "Grantee";

WITNESSETH:

That the Grantor, in consideration TWO HUNDRED ELEVEN THOUSAND, FIVE HUNDRED AND NO/100 DOLLARS (\$211,500.00), the receipt of which is hereby acknowledged, has bargained and sold and by these presents does bargain, sell and convey to the Grantee, and his heirs, successors and assigns, that certain real estate situate in Winston Township, Forsyth County, North Carolina, described as follows:

LYING AND BEING in Bethania Township, Forsyth County, State of North Carolina, and beginning at an axle in the northern right of way line of Wall Street, said axle being North 87° 36' 06" East 351.86 feet from the approximate center line intersection of Wall Street and N.C. Highway No. 66 and being the southeast corner of Thelma E. Smith (see Deed Book 724 at Page 91); and running thence along the eastern boundary line of Thelma E. Smith North 12° 43' 05" West 327.70 feet to an iron stake in the southern boundary line of William H. Pardue (see Deed Book 825 at Page 432); thence along the southern boundary line of William H. Pardue South 87° 41' 37" East 238.58 feet to an iron stake; thence along the western boundary line of Janet S. Celnar (see Deed Book 1755 at Page 3983) South 04° 49' 00" West 140.80 feet to an iron stake; thence continuing along the boundary lines of Janet S. Celnar South 85° 26' 52" East 100.07 feet to an iron stake and South 04° 50' 37" West 179.17 feet to an iron stake in the northern right of way line of Wall Street; thence continuing within said right of way South 04° 50' 37" West 20.83 feet to a point; thence within the right of way of Wall Street North 85° 26' 53" West 99.98 feet to a point; thence North 04° 49' 07" East 19.87 feet to a point in the northern right of way line of Wall Street; thence along the northern right of way line of Wall Street North 85° 59' 59" West 139.63 feet to the point and place of beginning, same containing 1.793 acres located outside the right of way of Wall Street and 0.047 acres located within the right of way of Wall Street, and being known as Tax Lot Nos. 37C and 107, Tax Block 4935, and being that same property surveyed and platted by Larry L. Callahan, R.L.S. on the 20th day of December, 1993 (Job No. 7567-3).

This Deed is being rerecorded for the purpose of revising the course of the first call appearing in the legal description and is one and the same as that deed recorded in Book 1810 at Page 669.

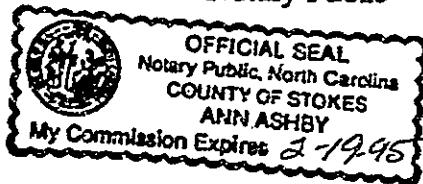
