THIS DEED made this the 3rd day of February, 1997 by and between B & B REALTY, a North Carolina General Partnership, hereinafter referred to as "Grantor" and REAL ESTATE TITLES, INC., a North Carolina corporation, hereinafter referred to as "Grantee".

W I T N E S S E T H:

THAT the Grantor, in consideration of One Hundred and No/100 (\$100.00 & OVC) Dollars and Other Valuable Considerations to it paid by the Grantee, the receipt of which is hereby acknowledged, has and by these presents does grant, bargain, sell and convey unto the Grantee in fee simple, all that certain lot or parcel of land in Forsyth County, North Carolina in Winston Township, more particularly described as follows:

BEGINNING at an iron in the northern right-of-way line of Fifteenth Street, said iron being at the southeast corner of the property of Eugene Attucks as described in deed recorded in Book 1186 at Page 528, Forsyth County Registry; thence from said beginning point along Attucks' east line North 02° 50' 05" East 140.00 feet to an iron in the southern right-of-way line of a 10-foot alley; thence along the south right-of-way line of said alley South 87° 09' 55" East 99.92 feet to an iron, the northwest corner of a tract formerly owned by B & B Realty as described in deed recorded in Book 1662 at Page 2326, Forsyth County Registry; thence along the west line of said tract formerly owned by B & B Realty South 02° 50' 05" West 140.00 feet to an iron in the northern right-of-way line of Fifteenth Street; thence along the northern right-of-way line of Fifteenth Street North 87° 09' 55" West 99.92 feet to the point and place of BEGINNING and being all of Lot 20 and part of Lots 19 and 21 Block 8, as shown on Map of Bramlette Place recorded in Plat Book 8 at Page 5 in the Office of the Register of Deeds of Forsyth County, North Carolina, all according to survey of Larry L. 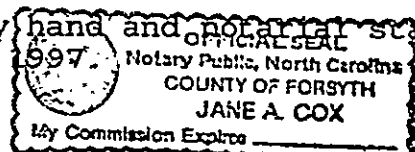
