- b) Any and all restrictions, easements, and rights-of-way of record.

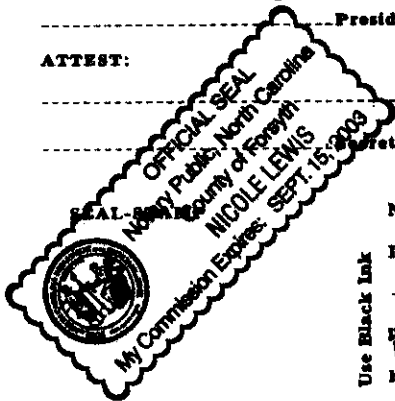
