**WITNESSETH THAT:**


**WHEREAS**, Ignacio Ocegueda E. and wife, Perla Ocegueda, on July 11, 1995, made and executed to Gary E. Lackey, Trustee, a Deed of Trust recorded in Book 1863 at Page 2920, Forsyth County Registry, upon the lands hereinafter described; and **WHEREAS**, Ignacio Ocegueda E. and wife, Perla Ocegueda, failed to comply with the terms of said Deed of Trust; and **WHEREAS**, PHILIP E. **NOW, THEREFORE**, for and in consideration of the premises and the sum of \$33,332.00 in hand paid to the said PHILIP E. SEARCY, Substitute Trustee, by the said Secretary of Housing and Urban Development of Washington, D.C., the receipt whereof is hereby acknowledged, the said PHILIP E. SEARCY, Substitute Trustee, does by these presents hereby sell and convey unto the said Secretary of Housing and Urban Development of Washington, D.C., its successors and assigns, the following tract and lot of land lying in the County of Forsyth and the State of North Carolina and described as follows:

BEING KNOWN AND DESIGNATED as Lot No. 16, as shown on the Map of Forest Park Terrace, as recorded in Plat Book 14, Page 10, in the Office of the Register of Deeds of Forsyth County, North Carolina, reference to which is hereby made for a more particular description.

**TO HAVE AND TO HOLD** the aforesaid tract or lot of land to the said Secretary of Housing and Urban Development of Washington, D.C., its successors and assigns, to its and their use and behoof forever; and the said PHILIP E. SEARCY, Substitute Trustee, covenants that he is seized of said premises and has the right to convey the same and that he will warrant and defend the title to the same insofar as it is his duty to do so by virtue of his office as Substitute Trustee and no further.

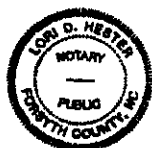


