This deed, made this 26th day of September, 2024, by MARK B. BARDILL, Commissioner, to Horacio Martinez Cadena and Eva Y Vargas Santos of 2059 Urban Street, Winston-Salem, North Carolina, 27107.

WITNESSETH:

That whereas the said MARK B. BARDILL was appointed Commissioner under an order of the District Court, in the tax foreclosure proceeding entitled Forsyth County versus Rae H. Lane and spouse, if any, and City of Winston-Salem, Defendants, and City of Winston-Salem, and Household Realty Corporation, Lienholders, et al, File No. 19 CvD 6750; and said MARK B. BARDILL was directed by said Order as Commissioner to sell the land hereinafter described at public sale after due advertisement according to law; and

Whereas, the said MARK B. BARDILL, Commissioner, did on the 8th day of February, 2024, offer the land hereinafter described at a public sale at the Forsyth County Courthouse door, in Winston-Salem, North Carolina, and then and there the said RVBC Enterprises, Inc. became the last and highest bidder for said land for the sum of \$2,200.00; and after said bid was upset, Horacio Martinez Cadena and Eva Y Vargas Santos became the last and highest bidder for said land for the sum of \$2,950.00; and no upset or increased bid having been made within the time allowed by law, and said sale having been confirmed by said Court, and said MARK B. BARDILL, Commissioner, having been ordered to execute a deed to said purchaser upon payment of the purchase money;

Now, therefore, for and in consideration of the premises and the sum of \$2,950.00, receipt of which is hereby acknowledged, the said MARK B. BARDILL, Commissioner, does by these presents, hereby bargain, sell, grant, and convey to the said Horacio Martinez Cadena and Eva Y Vargas Santos, and their successors, heirs and assigns that certain parcel or tract of land, situated in Winston Township, Forsyth County, North Carolina, and described as follows:


All that certain lot or parcel of land situated in Winston Township, Forsyth County, North Carolina, and more particularly described as follows:


